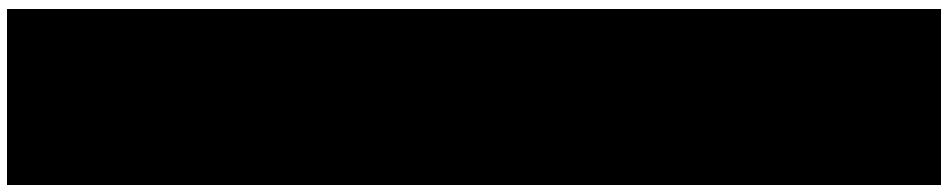

## **ACTION**

- 1 Welcome and apologies**  
The Chairman welcomed all present. There were no apologies for absence.
- 2 In accordance with Section 1(2) of the Public Bodies (Admission to Meetings) Act 1960, the Parish Council is invited to resolve that members of the public and representatives of the press be excluded from the meeting during consideration of item 3, as publicity would be prejudicial to the public interest due to the confidential nature of the business to be transacted**  
Agenda item 2 resolved under a resolution put forward by the Chairman and seconded by Councillor Wheeler.
- 3 To reconsider resolution passed on agenda Item 8 (to discuss the closure of the footpath of part of the footpath along The Cut, Mill Road and to consider whether a claim should be made for a Definitive Map Modification Order (DMMO) or alternative means of recording public rights) discussed at the Parish Council Meeting KPC 126-02 held on 06 October 2020, in consideration of new information coming forward**  
Councillor Carre-Skinner asked for it to be noted that she was not present at KPC meeting 126-02.

It was discussed that an "open letter" could be sent out to the whole village to give clarity on the situation, rather than a consultation letter.

A resolution was put forward by Councillor Wilsher and seconded by Councillor Naylor to modify the decision taken at the last meeting that a consultation letter be sent out to Parishioners but instead an "open letter" be drafted and sent out providing the facts of the matter, to give Parishioner the correct information on the piece of land adjacent to the Watermill. Also, that the Parish Council would not pursue the DMMO. There were no other resolutions; majority in favour; resolution carried.
